SECTION 4: FIRST AID MEASURES

4.1. Description of First Aid Measures

If any of the following delayed signs and symptoms appear within the next 6 hours, transport to the nearest medical facility: fever greater than 101° F (38.3°C), shortness of breath, chest congestion or continued coughing or wheezing. If vomiting occurs spontaneously, keep head below hips to prevent aspiration.

SECTION 5: FIRE-FIGHTING MEASURES

5.1. Extinguishing Media
